As we get ready to start 2006 with numerous events, I'd like to take this moment and thank all of the credit unions that have supported the Chapter for many years. It is because of your commitment to the Chapter that we are able to function and meet on a regular basis. The most notable fundraiser will be focused on the \$2.5 million commitment made to the new Dell Children's Medical Center of Central Texas.
