## Capital Area Food Bank of Texas

We are pleased to welcome the representative from the Food Bank to speak to us about what this organization does for our community. The mission of the Food Bank is to nourish hungry people and lead the community in ending hunger. In its 25<sup>th</sup> year of service, the Food Bank currently provides food and grocery products to 370 Partner Agencies in 21 Central Texas counties. In 2005, the Food Bank distributed more than 15 million pounds of food. The Food Bank service area covers 21,600 square miles in Central Texas.

Several of our credit unions have conducted food drives and collected donations for the Food Bank. We will also present a check to the Food Bank from the Chapter Spring Golf Tournament and the October meeting drawing.
