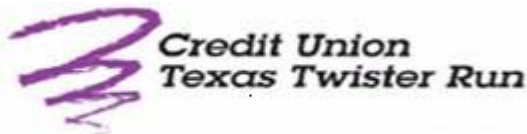
Welcome Mayor Will Wynn
